Nature of Acquisition : PERMANENT

Purpose of Acquisition: PLANNED DEVELOPMENT OF DELHI

These are the proceedings for determination of compensation under section 11 of the Land Acquisition Act in respect of land measuring 60 bigha 14 biswa situated in village Mahipalpur notified under section 4 vide notification No. F4(98)/64-L&H dt. 23.1.65 and under section 6 vide notification No. F4(98)/64-L&H dt. 7.12.66. The land is required by the Government, for a public purpose, namely, for the Planned Development of Delhi at public expense. Due publicity was given to the notifications and notices under section 9 & 10 of the aforesaid Act were issued to the interested persons to file their claims. The claims filed by the interested persons are discussed under the heading 'Claims'.

Measurement

An area measuring 60 bigha 14 biswa is being acquired in the present case. According to our record, this area was shown as under 'Status Quo'. However, after checking the files from the High Court, it revealed that orders of the High Court were regarding 'stay for dispossession'. As such, supplementary award in respect of 60 bigha 14 biswa is being drawn.

Assessment

Market Value

Market value is to be assessed keeping in view the prices prevailing on the date of notification under section 4 and other factors viz. situation, quality and nature of soil etc. The interested persons claimed compensation ranging between Rs. 4,000/- per bigha to Rs. 60,000/- per bigha, but did not produce any documentary evidence in support of their contention. Hence, no reliance can be placed on their claims. The field staff was directed to consult the revenue record. It appears from the record that Award Nos. 2182 to 2192 F were drawn in this village which relate to the same date of notification u/s 4 & 6 as in the present case. The rate assessed in Award No. 2182 was Rs. 1900/- per bigha for Block 'B' and Rs. 600/- per bigha for Block 'C'; ~~since the date of notification~~ 4/-

whereas in Award No. 2182 B, it was Rs.2850/-per bigha for Block 'A' Rs.1900/-per bigha for Block 'B' and Rs.600/-per bigha for Block 'C'. Since the date of notification u/s 4 is the same in the above awards ~~which~~ that in the present case, the above awards have been made the basis for assessing the market value in this case. It appears that some persons had filed reference u/s 18 against Award No. 2182 B and the ld. ADJ had enhanced the compensation of Block 'A' from Rs.2850/-per bigha to Rs.4650/-per bigha. The Legal Adviser, Land & Building Department however had concurred with the rates upto Rs.3750/- per bigha and had advised to file appeal over and above Rs.3750/-per bigha. The kind of land in the present case is similar with that of the land of Block 'A' acquired in Award No.2182 B. I, therefore, feel that it would be justified and fair if a sum of Rs.3750/-per bigha is assessed in the present case & I award the same accordingly.

Well, Tree & Structure

There is reported to be no well, tree and structure on the land under acquisition ^{as such} no compensation is assessed.

Solatium

As provided under sub-section 2 of Section 23 of the Land Acquisition Act, the interested persons will be paid 30% solatium on the market value of land due to compulsory nature of acquisition as per provisions of the Land Acquisition (Amendment) Act, 1984.

Interest

Since the possession the land has not been taken, the interested persons are not entitled for any amount of compensation

Land Revenue

The land under acquisition is assessed to land revenue amounting to Rs.19.67 which will be deducted from the khalsa rent-roll of the village by which time possession under the award would be taken by the Govt.

Additional Amount

The interested persons are entitled for additional amount @ 12% from the date of notification u/s 4 till the date of award or date of possession whichever is earlier.

It appears from the record that court had issued 'Status Quo' ORDER on 5.7.83 in c.W.No.1386/83 in case 'Ram Sarup etv. vs. UOI' in respect of kh. No.s 342/1(2-08), 379/1/2(0-05), 379/2/2(2-03), 383/1/2(0-12), 383/2/1(1-16), 385/3(1-12), 856/2(2-01), 862/1(1-02), 863(4-15) 867/2(3-16), 940/2(1-10), 947/1(3-00), 955/1(0-02), 961/2(1-09), 962/1(2-08), 964/1(1-06), 971/1/2(2-04), 976/2(1-03), 976/3(1-05), 977/1(1-12), 977/2(1-16), 979/1(0-01), 984/2(1-03) and 1002(4-16) (total measuring 44 bigha 05 biswa). In c.W. No. 421/84 in case 'Sh. Prithi etc. vs. UOI' in respect of Kh. No. 385(4-09), 386/2(-4-16), 405/2(2-08) and 404(4-16) total measuring 16 bigha 09 biswa issued stay dispossession order on 25.4.84. In CW No. 1386/83, the court had later on modified the 'status quo order' to the extent of 'stay dispossession' on 19.9.83. Thus, the interested persons are ~~not~~ entitled for additional amount @ 12% as well as u/s 4(3) @ 6% from the date of the notification u/s 4 till the date of order of the court.

Apportionment

The payment of compensation will be made to the interested persons according to the latest entries available in the revenue record. In case of any dispute rising in the apportionment of compensation, the matter will be referred to the court of ADJ : Delhi u/s 30 - 31 of the L.A. Act.

DRAFT NOTIFICATION UNDER SECTION 4 ACT, 1894.

No. F. 4(98)/64-244:-

Dated the 23 January, 1965.

Whereas it appears to the L.G. Delhi, that land is likely to be required to be taken by Government at the public expence for a public purpose namely for, Planned Development of Delhi. It is hereby notified that the land in the locality described below is likely to be required for the above purpose.

The notification is made, under the provisions of section 4 of the Land Acquisition Act, 1894, to all whom it may concern.

In exercise of the powers conferred by the aforesaid section, the Lt. Governor is pleased to authorise the officers for the time being engaged in the undertaking with their servants and workmen to enter upon and survey any land in the locality and do all other acts required or permitted by that section.
