

AWARD No. 31/8-87
Name of Village : MAHIPAL PUR
Nature of Acquisition: PERMANENT
Purpose of Acquisition: PLANNED DEVELOPMENT OF DELHI

These are the proceedings for determination of compensation under section 11 of the Land Acquisition Act in respect of land measuring 14 bigha 08 biswa situated in village Mahipal Pur notified under section 4 of the L.A. Act vide notification No.F4(98)/64-L&H dt. 23.1.65 and under section 6 vide notification No.F4(98)/64-L&H dt. 26.12.68. The land is required by the Government, for a public purpose, namely, for the Planned Development of Delhi at public expense. Due publicity was given to the notifications and notices under section 9 & 10 of the aforesaid Act were issued to the interested persons to file their claims. The claims filed by the interested persons are discussed under the heading 'claims'.

Measurement

An area measuring 14 bigha 08 biswa is being acquired in the present case. According to our record, this area was shown as under 'status-quo'. However, after checking the files from the High Court it revealed that order of the High Court was regarding 'stay for dispossession' as such supplementary award in respect of following khasra Nos. is being drawn. Measurement was found to be correct at site.

Claims :

The following interested persons have filed their claims :-

Market Value

Market value is to be assessed keeping in view the prices prevailing on the date of notification under section 4 and other factors viz., situation, quality and nature of soil etc. The interested persons claimed compensation @ Rs.60/-per sq. yds for land but did not produce any documentary evidence in support of his contention. Hence, no reliance can be placed on his claim.

The field staff was directed to consult the revenue record. According to their report, One Award No. 30/72-73 was announced which relates to the notifications u/s 4 & 6 involved in the present case. A sum of Rs.2850/-P.B. was assessed for Block 'A' and Rs.1900/-P.B. was assessed for Block 'B' in the above award. As stated in the present case, the land in the present case is part of notification u/s 6 which was acquired in the above award. The date of notification under section 4 is the same in both the cases. Thus, it will be fair and justified if the same rates are applied in the present case. The nature of land in the present case is similar with that of block 'A' of the above Award No. 30/72-73 in which a sum of Rs.2850/-per bigha was assessed. It further appears that some of the land owners had filed a reference under section 18 before the court of ADJ in L.A. Case No. 38/73 - 'Jat Ram Vs. Union of India'. The ld court of ADJ has enhanced the compensation of Block 'A' from Rs.2850/-per bigha to Rs.4650/-per bigha. The Legal Adviser, Land & Building Department however, concurred with the rates upto Rs.3750/-per bigha and had advised to file appeal over and above Rs.3750/-per bigha. Taking all the above facts in view, I feel that the rates of Rs.3750/-per bigha would be reasonable and justified and assess the same for the land under acquisition.

Structures

No structures ^{u/s} are reported to be in existence at the time of notifications/4 as per entries in the khasra girdawari and as such, no amount is assessed on this account.

Wells

There is reported to be no well on the land under acquisition and as such, no compensation is assessed.

Trees

There is reported to be no tree on the land under acquisition as such no compensation is assessed.

Solatum

As provided under sub-section 2 of Section 23 of the Land Acquisition Act, the interested persons will be paid 30% solatium

on the market value due to compulsory nature of acquisition as per provisions of the Land Acquisition (Amendment) Act, 1984.

Interest

Since there is a difference of more than three years between the dates of notifications u/s 4 & 6, the interested persons are entitled for interest @ 6% u/s 4(3) of the L A Act after expiry of three years from the date of notification u/s 4.

Additional Amount

The interested persons are entitled for additional amount @ 12% from the date of notification u/s 4 till the date of award or date of possession whichever is earlier.

It appears from the record that court had issued 'status quo' order on 20.5.83 in civil writ No. 1007/83 in case of 'Manphool Singh etc. Vs. Union of India' which was later on modified to the extent of 'stay dispossession' on 12.9.83. Thus, the interested persons are ~~not~~ entitled for additional amount @ 12% as well as interest u/s 4(3) @ 6% from the date of notification u/s 4 i.e. 23.1.65 till the date of order of the court.

Land Revenue

The land under acquisition is assessed to land revenue amounting to Rs. 3.34 which will be deducted from the khalsa rent roll of the village by which time possession under the award would be taken by the Government.

DRAFT NOTIFICATION UNDER SECTION 4 ACT, 1894.

No. F. 4 (98)/64-1241- Dated the 23 January, 1965.

Whereas it appears to the L.C. Delhi, that land is likely to be required to be taken by Government at the public expense for a public purpose namely for, Planned Development of Delhi. It is hereby notified that the land in the locality described below is likely to be required for the above purpose.

The notification is made, under the provisions of section 4 of the Land Acquisition Act, 1894, to all whom it may concern.

In exercise of the powers conferred by the aforesaid section, the Lt. Governor is pleased to authorise the officers for the time being engaged in the undertaking with their servants and workmen to enter upon and survey and land in the locality and do all other acts required or permitted by that section.

Any person, interested, who has any objection to the acquisition of any land in the locality, may within 30 days of the publication of the notification file an objection in writing before the Collector of Delhi.
