Documentary Evidence

No body has produced any documentary proof in support of his chaim for compensation.

Market Value:-

The market value of the land under acquisition has to be fixed with reference to the price prevailing on the date of preliminary notification U/s 4 of the L.A.Act with all its advantages and with all its potentialities.

Efforts were, however, made at this end to find out the parallel sale deeds in the Village nearest to the material date so as to evaluate to the material date so as to evaluate the market value of the land. The statement showing the details of the sale-deeds, which were executed in Village Masqodabad are given below:-

The sale deeds at Sl. No. 1 & 2 relate to Kh. No. 241, which abuts on the Delhi Najaf Garh Road, where as the land under acquisition is at a distance of two Kilo metre. And the land covered under these sale deeds in situated in a more advantages position than the land under acquisition and as such these deeds will not give useful guidence in assessing the fair market value of the land under acquisition.

In award No. 28/76-77 of Village Mascodabad land was acquired for construction of Najafgarh Ponel Drain and the Collector awarded.

Rs. 1800/- per bigha Kham. The land acquired vide this award is situated in close proximity of the land under acquisition. Thus award No. 28/76-77 is by for the best example in assessing the fair market valued of the land under acquisition. The date of preliminary notification of award No. 28/76-77 is 29.12.75, where as the date of preliminary notification of the present award is 30.5.1979

Thus there is a time gap of four years 5 months. Some appreciation will hence to be given while assessing the market value of the land under acquisition. In view of circumstances I determine No. 2000/- as fair market value of the land in question.

TREES, WELLS & STRUCTURES

There is no tree, well water and structures on the land under acquisition.

Interest

The acquiring department has taken the possession of the land under acquisition on 30.11.79. The persons interested are, therefore, entitled to interest U/s 3,4 of the LA ACt wef 30.11.79 till the date of announcement of the award.
