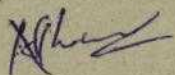
These are proceedings for the determination of compensation u/s 11 of the Land Acquisition Act, 1894 in respect of land measuring 263 bighas 05 biswas situated in Village Khadi Nangal Dewat which was notified u/s 4 of the Land Acquisition Act vide notification No. F.15(38)/64-L&H dated 28.4.72 for a public purpose namely for development of Palam Airport. Delhi Administration vide notification u/s 6 bearing No. F.15(38)/64-L&H dated 22.8.72 issued declaration for acquisition of an area 237 bighas 9 biswas of land.

In pursuance of the aforesaid notification notices u/s 9 & 10 of the Land Acquisition Act were issued to all the persons interested in the land and the claims filed by them are discussed hereafter under the heading "Compensation Claims."

TRUE & CORRECT AREA

There is a difference of 24 bigha 4 biswas in declaration u/s 6 and area under acquisition. It is on account of Government land comprising of Kh.No. 715/1, 1191, 1234, 1235/1, and 1242/1 which is not being acquired being government land. The Acquiring Department may take the possession of the said land through book transfer. Hence the acquisition proceedings are confined to an area measuring 263 bigha 5 biswas. The area of Kh.No. 1198, 1242, and 1243 measuring 89 bigha 2 biswas is converted into sq.yds. for the purpose of measurement which comes to 89796 sq.yds. and the area of remaining khasra numbers under acquisition is 174 bigha 03 biswas. The aforesaid land under acquisition was measured on the spot and area found available is as under :-

MARKET VALUE

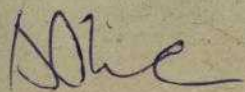
The entire land under acquisition falls in Village on abadi and has enjoyed all basic amenities. The major area of agriculture land of this Village was acquired through award No. 23/73-74. The date of notification u/s 4 in award No. 23/73-74 was 3.12.1971 whereas the land under acquisition is notified u/s 4 on 28.4.1972. The market value assessed for the agriculture land cannot be taken into consideration for the purpose of assessing the market value of the land under acquisition being abadi deh. In this Village a small piece of land measuring 100 sq. yds. was sold out and was used for residential purpose. The said plot was acquired in Award No. 23/73-74. The petitioner namely Ram Phool had gone into reference u/s 18 of the L.A. Act against the low quantum of compensation awarded by L.A.C. The Ld. ADJ, Delhi in LAC No. 19/74 styled as Ram Phool Vs. UOI decided on 31.1.77 had assessed the compensation of this small piece of land measuring 100 sq. yds at Rs. 2378-00/- (Rs. 23.78 P. per sq. yd). No appeal against this decision was filed in Delhi High Court. Hence, it is clear that the market rate for the residential purpose were more or less Rs. 23.78 P. at the time of notification u/s 4 dated 3.12.1971. There is time gap of 4 months and 26 days in between the notification u/s 4 of award No. 23/73-74 and land under acquisition.

Taking into consideration all facts and trend of increase in prices of land as well as time^{gap} of 4 months and 26 days I am of the opinion that Rs. 24/- per sq. yd for land under acquisition is fair and reasonable and award the same accordingly.

STRUCTURES

There are structures/houses on the land under acquisition. The list of these structures/houses along with valuation is attached, therein the valuation estimate was prepared by the Surveyor of Works. I agree with the Valuation prepared by the Surveyor and award the same accordingly.

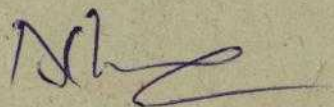
