MARKET VALUE

The registration deed filed by Sarvshri Bharat Singh, iranjan Singh was executed on 23.8.75 by Sh. Suba Singh S/o akam Singh, Jag Ram S/o Hukam Singh, Rajinder Singh, S/o Late aroop Singh and Smt. Sarwan Devi Ed/o Sarcop Singh and others inors in favour of Sh. Chaman Lal Bahris/o Khewan Mal Bahri egident of R/18, Indira Market, Subzi Mandi, Delhi and others. his sale deed is in respect of land measuring 12 bigha 3 biswas Rantangly No. 1 and Rantangly No. 2 in the revenue estate of

llage Nilothi. Sh. Suba Singh one of the interested erson have also filed registration deed No. 2872 dated 3.8.75 which was executed on 28.8.75. This registration eed pertain to the land measuring 9 bigha 12 biswas ituated in Rectangle No. 6 in the Revenue Estate of village Nilothi. The price obtained for the sale of the land is &. 33000/-. Another sale deed filed by Sh. Suba Singh for a sum of Rs. 42000/- which was also executed on 28.8.75 pertain to the land measuring 12 sigha 3 biswas situated in Rectangle No. 2. The cost of the well and one grown up tree is also included in the sale price of k. 42000/-. Another two sale deeds amounting to Rs. 49000/for the land measuring 14 bigha 8 biswas and another sale deed for R. 15000/- in respect of land measuring 4 higha 4 bixwas in Rectangle No. 45 were also filed, but after the date prescribed for receipt the objections. I have give throughful consideration to the sale deed filed by the interested persons in support of there claims.

The value of the land under acquisition is to be assessed, keeping in view the advange and the potentialities attached to it. The another important consideration in deciding the market value is the sale price determined on basis of registration deeds executed with the reasonable time, before and after the notification of the intention of the Govt. to acquire as required under section 23 of the L.A.Act 1894. The proof of the aforesaid sale transactions submitted by the interested perso pertain to the year 1975. The average sale price on basis of the registration deed submitted comes to Rs. 3437.60 paise per big The notification for acquisition of land was issued by the Govt. Therefore thus, has been a gap of 4 years in transaction of the land and the notification of the Govt, for acquiring to land. In the meanwhile the interested persons had filed an Appeal against the Collector Saward No. 24/78-79 in the Court o A.D.J. The Learned A.D.J. in his order dated 30.11.79 in L.A. case No. 18/79 Kanwar Singh and other Vs. Union of India has enhanced the amount of award from Rs. 1750/- to Rs. 4000/- per bigha. The land under acqusition by this award is in the same vicinity and has the same potentialities. Therefore, in all fairness I determine the present market value of the land keeping, all the facts in mand to Rs. 4000/- per bigha.

TREES, WELLS & STRUCTURES.

There is no trees, wells and structure on the land under acquisition.
