PURPOSE OF ACQUISITION : CONSTRUCTION OF MINORS

These are proceedings for determination of compensation under section 11 of the Land Acquisition Act, 1894. The land measuring 62 bighas 19 biswas situated in village Nilothi was notified u/s 4, 6 and 17 of the Land Acquisition Act, vide Delhi Administration Notification Nos. F.7(56)/76-L&B(1), F.7(56)/76-L&B(ii) and F.7(56)/76-L&B(iii) dated 18.8.78 respectively for a public purpose, namely Construction of Minors. Notices u/s 9 and 10 of the Land Acquisition Act were issued to the persons interested and claims filed by them are discussed hereafter the heading 'Compensation Claims'.

TRUE & CORRECT AREA :

The land for the purpose of acquisition was notified under the notification referred to above u/s 4, 6, 17 of the Land Acquisition Act was 62 bighas 19 biswas. The acquiring department, i.e., Minor & Irrigation, Sub-Division, Delhi Administration Delhi has desired that an area measuring 17 bighas and 17 biswas bearing Kh.No.16 Rect./8,9,12,13,18,19,22 & 23; Rect.No.27/2,3,8,9,12,18,19,22 & 23; Rect.No.32/2,4,8,12,20,21; Rect.No.33/16 & 25; Rect.No.42/1,10,11,20 & 21; Rect.No.44/1 & 10 may not be acquired at present. Therefore, the remaining land was measured on the spot by the Land Acquisition Field Staff and area was found 44 bighas 13 biswas. The possession of 44 bighas 13 biswas accordingly was handed over to the acquiring department on 10.1.79. The released area from this award measuring 17 bighas and 17 bis. will be acquired by a supplementary award as and when the acquiring department desires to acquire the same. There is, therefore, a difference of 6 biswas which is due to the titanna of the Kh.Nos. 27/16/1/1 measuring 4 biswas but has been notified as 7 biswas.

DOCUMENTARY EVIDENCE :

The persons interested, i.e., S/Sh.Mange Ram s/o Ram Nath, Dhan Singh s/o Lekh Ram, Deep Chand s/o Meer Singh, Dharam Pal s/o Chandgi and Anand Pal s/o Chandgi r/o village Nilothi, Delhi, have produced sale deeds No.11732 and 11673 as documentary evidence in support of their claims.

MARKET VALUE:

The market value of the land under acquisition is to be assessed after keeping in view the advantages and potentialities attached to the land. The other important factors as contemplated u/s 23 of the Land Acquisition Act which guides the Land Acquisition Collector in assessing the amount of the compensation is the market value of the land at the date of publication of notification u/s 4 of the Land Acquisition Act. Transaction of transfer of property affected around the time of publication of such notification can obviously prove the best guide for

such market value. Previous awards of the village & judicial decision can also afford guidance in determining the market value of the land.

The persons interested have filed the copy of the sale deed No.11732 & 11673 as documentary evidence in support of their claims. The land concerned under sale deeds produced by the interested persons is situated far away from the land under acquisition and therefore cannot help in assessing the correct market value of the land under acquisition.

The following awards have been drawn in this village.

Award mentioned at Sl.No.1,2 & 3 cannot be made the basis for determining the market value of the land under consideration because their date of material notification u/s 4 is of an early period than the date of notification of the land under acquisition. However in Award No.24/78-79, where the date of notification was 18.3.77, the Land Acquisition Collector awarded a flat rate of Rs.1750/- per bigha kham. Though there is a gap of about 1½ year difference between the date of preliminary notification of Award No.24/78-79 and ~~the~~ of the land under acquisition, this can afford a best guidance for determining the market value of the land under acquisition. There is a similarity of the kind of land, situation of the land between the land acquired vide Award No.24/78-79 and land under acquisition. I feel it shall be fair and just if the market value of the land under acquisition is determined with some appreciation of the value of the land determined in Aw.No. 24/78-79. I, therefore, assess the market value of the land under acquisition at the flat rate of Rs.1850/- per bigha kham.

DAMAGES:

In the following K h.Nos. wheat crops were

the time of handing over the possession to the acquiring department on 10.1.79. The wheat crops standing thereon on a total area measuring 26 bighas 3 biswas (details given below) was destroyed by digging the land. The acquiring department has agreed to pay the damages at the same. Rs.200/- per bigha kham as production price of wheat generally accepted in that locality is allowed. Thus Rs.5230 is awarded as production price of wheat on 26 bighas 3 biswas land which was destroyed at the time of handing over the possession to the acquiring department.

INTEREST :

The possession of the land under acquisition has been taken over and handed over to the acquiring department on 10.1.79. The interest is payable to the persons interested as per Land Acquisition Act, from the date of possession i.e. 10/1/79 to the date of announcement of the award.

PROPORTIONMENT:

The payment of compensation will be made according to the latest entries in the revenue record.

LAND REVENUE :

The land under acquisition is assessed to Rs.14-79 P which will be deducted from the Khalsa Rent Roll of the village from the date of possession i.e. 10/1/79.

F 7(56)/76-L&B(1):- Whereas it appears to the Lt. Governor, Delhi, that the land is likely to be required to be taken by Government at the public expense for a public purpose, namely, for construction of Minors, it is hereby notified that the land in the locality described below is likely to be acquired for the above purpose.

This notification is made under the provisions of section 4 of the Land Acquisition Act, 1894 to all whom it may concern.

In exercise of the powers conferred by the aforesaid section, the Lt. Governor is pleased to authorise the Officers for the time being engaged in the undertaking with their servants and workmen to enter upon and survey any land in the locality and do all other acts required or permitted by that section.

The Lt. Governor being of the opinion that provisions of sub section (1) of the section 17 of the said act are applicable to this land, is further pleased under sub section of the said section, to direct that the provisions of section 5-A shall not apply.
