PURPOSE OF ACQUISITION

CONSTRUCTION OF MINORS.

These are proceedings for determination of compensation u/s 11 of the Land Acquisition Act, 1894. The land measuring 02 biswax in village Nilothi was notified u/s 4 vide No.F.7(56)/3 76/L&B dated 18.8.78. Further a declaration u/s 6 of the L.A. At vide No.F.7(56)/76/L&B dated 2.6.81 was made for the acquisition of land in village Nilothi for Constructions of Minors Notices u/s 9 & 10 were issued to the persons interested to file their respective claims. Those who filed claims are discussed under the heading 'Claims'.

TRUE & CORRECT AREA

The land now under acquisition as 02 biswas as notified u/s 4 & 6 referred to above and the same was found correct when measured and marked by revenue staff on the spot. The details are as under:-

CLATMS

Notices u/s 9 & 10 of the L.A. Act were issued & served on the persons interested to file their respective claims but no one filed any claim mather any person interested filed any evidence in respect of notices served on them.

MARKET VALUE

The market value of the land now under acquisition is to be assessed after keeping in view the advantages & potentialities attached to the land at the date of notification issuedu/s 4 of the L.A.Act i.e. 18.8.78.

To decide the compensation of the land the record of this office was consulted and it was seen that award No.13/79-80 has been announced in this village and the date of notification will is the same as in the instant case. Therefore, the market values assessed in this award was k. 1850/-per bigha. As the

notification u/s 4 is the same in both the case, the quality of the land is also the same, I assess Rs. 1850/- per bigha as market value for the land now under acquisition.

OTHER COMPENSATION

There is no tree, well or structure on the land now under acquisition as per revenue record. Hence the interested personsuc are not entitled for any compensation on this account.

TUBEWELL

As such the persons interested are entitled for compensation at 8.1500/. The description is as under:-

SOL ATIUM

30% solatium is payable to the interested persons on market value of the land.

INTEREST

The possession of the land now under acquisition has not been taken over so far. Hence the persons interested are not entitled for any compensation on this account.

ADDITIONAL AMOUNT

The persons interested are also entitled for admitional compensation calculated @ 12% p.a. on the market value of the land now under acquisition from the date of notification u/s 4 i.e. 18.8.78 till the date of announcement of the award.

APPORTI ONMENT

The compensation will be paid according to the latest entries in the revenue record of the land now under acquisition. In case of any dispute, the matter will be referred to the court of Additional District Judge, Delhi u/s 30-31 of the L.A. Act for aljudication.
