DRAINAGE.

These are proceedings for determination of compensation u/s 11 of the Land Acquisition Act, 1894. The land measuring 735 aighas 18 biswas situated in village Nilothi was notified u/s 4, 6 & 17 of the Land Acquisition Act vide Delhi Administration notification No. P.7(73)/78-L&S dated 30.5.1979 for a public purpose namely increasing capacity of Rajgarh Drain. ✓

Notices u/s 9 & 10 of the L.A. Act were issued to the interested persons and claims filed by them are discussed hereafter the heading "Compensation claims".

TRUE AND CORRECT :-

The land was got measured on the spot by the Land Acquisition field staff and found 649 aighas 14 biswas instead of 735 aighas 18 biswas as notified u/s 4, 6 & 17 of the L.A. Act of the aforesaid notification, the difference of 87 aighas 04 biswas is due to already acquired vide award No. 38/72-73 of this village and difference of one aigha is due to

MARKET VALUE :-

The Market value of the land under acquisition is to be determined after keeping in view the advantages and potentialities attached to the land and with reference to the price prevailing at the date of notification u/s 4 of the Land Acquisition Act. The best evidence available to arrive at the correct market value of the land would be the evidence of genuine sales effected about the time of notification either in respect of the land under acquisition or the portion thereof or sales of land precisely parallel in all circumstances to the land under acquisition. In this village an award No. 72/80-81 @ Rs.4000/- per bigha was given by the Land Acquisition Collector on 4.10.80 under the Minor irrigation scheme. The land under acquisition is parallel in all circumstances to the land acquired vide award No. 72/80-81 except that of Gaon Saha area which is precisely a Sanjer Qadir. I, therefore, determined the market value of the land under acquisition @ Rs.4000/- per bigha except that of the Gaon Saha area measuring 5 bighas 05 aiswas. The valuation of the Gaon

Saaha land is determined @ Rs.1500/- per bigha being Banjar Qadim. Rest of the Saon Saaha land measuring 8 Bighas 14 Biswas recorded as Rasta & Pond. No compensation is awarded for the same. This area is used as Rasta for public utility.

At the time of taking over the possession of the land on 23.11.79, the Rabi crop was sown in an area measuring 585 Bighas 12 Biswas as per possession report. The Wheat and Barseem were the standing crop in the land under acquisition. The claimants have demanded damages of crop at Rs.4000/- per bigha which is most unreasonable. The crop was at the initial stage during the month of November. Taking into account the labour, seeds and fertilizers used, I assessed the damages @ Rs.200/- per bigha and awarded the same.

OTHER COMPENSATION :- There are no wells, trees and structures on the land under acquisition.

15% SOLATIUM :- 15 % solatium will be payable to the interested persons on the market value of the land as compulsory nature of acquisition.

INTEREST :- 6% interest on the market value of the land under acquisition is admissible to the interested persons from the date of taking over possession i.e. 23.11.79 till the date of announcement of the award.

APPROPRIATION :- The payment of compensation will be made according to the latest entries in the revenue records.

LAND REVENUE :- The land under acquisition is assessed to Rs.161.50P. as land revenue which will be deducted from the Khasra Rent Roll of the village from the date of taking over possession i.e. 23.11.79.

SUPPLEMENTARY AWARD No. 30/82-83

These are the supplementary proceedings of Award No. 30/82-83 of an area measuring 649 Bighas 14 Biswas of village Nilothi was announced on 22.7.82. The land of that award was notified u/s 4, 6 & 17 of the L.A. Act vide notification No. F.7 (73)/78-L&B dated 30.5.79. The possession of that land was taken and handed over to the acquiring department on 23.11.79. In that award solatium @ 15% was given and interest u/s 34 of L. Act w.e.f. 23.11.79 to 20.7.82 (2 years 240 days) was calculated @ 6% P.A. After the announcement of the above award, the Land Acquisition Act, 1984 has been amended on the amendment Act came into force w.e.f. 24th Sept., 1984.

As per provisions of land Acquisition (Amendment) Act, 1984, the interested are entitled to get the payment of solatium @ 30% on the market value, Additional amount on the market value @ 12% P.A. from the date of notification u/s 4 of the L.A. Act to the date of possession w.e.f. 30.5.79 to 23.11.79 (177 days) and interest u/s 34 of the L.A. Act @ 9% P.A. from the date of possession to the date of award of the Collector.

As the above discussed, the amount as detailed below allowed to the interested persons of award No. 30/82-83 of this village, the amount already assessed under this award will be deducted.
