NAME OF THE VILLAGE : NILOTHI

NATURE OF ACQUISITION : PERMANENT

PURPOSE OF ACQUISITION : CONSTRUCTION OF MINORS.

These are proceedings for determination of compensation u/s 11 of the Land Acquisition Act, 1894. The land measuring 8 bighas 6 biswas situated in village Nilothi was notified u/s 4,6 and 17 of the L.A. Act, vide Delhi Administration Notification Nos.F.7(4)/77-L&B Vol-II (1) dated 15.7.1978 for a public purpose, namely for Construction of Minors.

Notices u/s 9 and 10 of the L.A. Act were issued to the persons interested hereafter the heading 'Compensation Claims'.

TRUE & CORRECT AREA

The land under acquisition was measured on the spot by the Land acquisition field staff and area found available for acquisition was 8 bigha 6 biswas as notified.

DOCUMENTARY EVIDENCE

The claimants have produced a sale deed No. 19279 dated 7.12.74 for an area measuring 10 bighas 7 biswas against a consideration of Rs.48000/- relating to village Qamnuddin Nagar in support of their claims.

MARKET VALUE

The market value of the land under acquisition is to be assessed after keeping in view the advantages and potentialities attached to the land. The other important factors as contemplated u/s 23 of the Land Acquisition Act which guides the Land Acquisition Collector in assessing the amount of the compensation is the market value of the land at the date of publication of notification u/s 4 of the LAND ACQUISITION Act. Transaction of transfer of property affected around the time of publication of such notification of such notification can obviously prove the best guide for

deciding such market value. Previous awards of the village and judicial decision can also afford guidance in determining the market value of the land.

The persons interested have filed the copy of the Sale Deed No. 19279 dated 7.12.74 as documentary evidence in support of their claims. This sale deed relates to village Qammurdin Nagar which is far away from the land of Nilothi under acquisition and therefore cannot help in assessing the correct market value of the land under acquisition. In the absence of any relevant documentary evidence produced by the claimants, the record of Land Acquisition was consulted and the following awards were found to have been drawn in this village:-

The award mentioned at serial No. 1 to 4 cannot be made the basis for determining the market value of the land under consideration because their date of material notification u/s 4 is of an early period than the date of notification of the land under acquisition. However, in award No. 13/79-80, the date of notification was 18.8.88 ^{and} the Land Acquisition Collector awarded a flat rate of Rs.1850/- per bigha kham. The date of notification u/s 4 of the Land under acquisition is 15.7.78 i.e. near to the date of notification of award No. 13/79-80. The land under acquisition is also in the near

vicinity of the land which was acquired vide award No. 13/79-80 of village Nilo thi. There is also a similarity of the kind of land acquired vide award No.13/79-80 and the land under acquisition. Therefore, award No.13/79-80 can afford the best guidance for determining the market value of the land under acquisition. I, therefore, feel it shall be fair and just if the market value of the land under acquisition is determined at Rs.1850/- per bigha kham.

TREES, WELLS AND STRUCTURES

There are no trees, wells and structures on the land under acquisition.

SOLATIUM

15% solatium is admissible on the amount of compensation as per Land Acquisition Act.

INTEREST

The possession of the land under acquisition has been taken over and handed over to the acquiring Deptt. on 14.6.79. The interest is payable to the persons interested as per Land Acquisition Act from the date of possession i.e. 14.6.79 to the date of announcement of the award.

APPORTIONMENT

The payment of compensation will be made according to the latest entries in the revenue record.

LAND REVENUE

The land under acquisition is assessed to Rs.2.55P which will be deducted from the Khalsa Rent roll of the village from the date of possession i.e. 14.6.79.

No. F 7(4)/77-L&B Vol II (1):- Whereas it appears to the Lt. Governor, Delhi, that the land is likely to be required to be taken by Government at the public expense for a public purpose, namely, Keshpur Effluent Irrigation Scheme, it is hereby notified that the land in the locality described below is likely to be acquired for the above purpose.

This notification is made under the provisions of section 4 of the Land Acquisition Act, 1894 to all whom it may concern.

In exercise of the powers conferred by the aforesaid section, the Lt. Governor is pleased to authorise the Officers for the time being engaged in the undertaking with their servants and workmen to enter upon and survey any land in the locality and do all other acts required or permitted by that section.

The Lt. Governor being of the opinion that provisions of sub section (1) of section 17 of the said act are applicable to this land, is further pleased under sub section 4 of the said section, to direct that the provisions of section 5-A shall not apply.


