These are proceedings for acquisition of land in Village Rajokri which is required by the Government at public expense for public purpose namely for the construction of Rajokri Bund No. II. This land was notified under section 4,6,17 of the Land Acquisition Act, 1894 vide notification No. F. 7(41)/81-L&B(1)(2)(3) dated 22.1.82 respectively. A declaration w/s 6 of the said Act was issued vide notification No. F. 7(41)/81-L&B(2) dated 22.1.82 for the land measuring 7 bighas 19 biswas. The notices u/s 9 & 10 of the L.A. Act were issued to the interested persons for filing claims who have responded to the notices and have filed their claims which will be discussed under a separate heading ''Claims & Evidence.''

The references us 18 have been filed by the persons interested but none of them have been decided so far.

MARKET VALUE

In the present case the date of preliminary notification is 22.1.1982 & as such the market value is to be determined as prevailing during that period. The claimants have demanded exhorbitany rates of compensation. A few sale deeds have also been produced.

All this evidence pertain to land which has been de-notified w/s 48(1) of Land Acquisition Act, 1894 and was thus not acquired. The actual claimants left in the award have not filed any claim what-so-ever.

Before I embark upon the private sale transactions in determining the market value, it would be helpful to look into the awards that have been drawn in respect of this Village. The only award drawn is No. 22/78-79 dated 24.3.77 where the compensation per bigha was determined @ Rs. 1623-80 Ps for Abpash land & Rs. 1123/80 for Gair Abpash land. References filed have not so far been decided by the Ld. ADJ.

Since, the above award is of much earlier date and prices of land have gone up during the intervening period as is evident from the private sale transactions which have taken place during 1979, 1980 & 1981 i.e. earlier than the date of notification.

Average sale price of the 3 years i.e. 1979, 1980 & 1981 comes to N. 6635-72 per bigha or N. 6636/- per bigha in round figure. I consider N. 6636/- per bigha as a just market value of the land under acquisition and I assess the same accordingly.

WELL & TREE

There is no Well or a Tree on the land under acquisition. Hence, no compensation is assessed for the same.

There is no structure on the land under acquisition.

The question of payment of structure does not arise.

INTEREST

Since the possession of the land measuring
2Bigha 9 Biswa has been taken over on 22.3.1982, they will be
given interest @ 9 % from 22.3.1982 till the announcement of
the award.

SOLATIUM

LAND REVENUE

As provided under sub-section 2 of section 23 of the L.A. Act, the interested persons will be paid 30 % on the market value of the land due to compulsory nature of acquisition as per provisions of the Land Acquisition (Amendment) Act, 1984.

POSSESSION

Possession of the land under acquisition measuring 2 Bigha 9 Biswa has been taken over on 22.3.83.

ADMITIONAL AMOUNT

The interested persons are entitled for additional amount @ 12 % on the market value of the land w.e.f. notification w/s 4,6 and 17 till the date of possession or the award is drawn, whichever is earlier as per provisions of the Land Acquisition (Amendment) Act, 1984.

The land in question is assessed to sum of Rs.O.44 Ps as land revenue. The same may be deducted from the Khalsa Rent Roll of the Village w.e.f. the date of taking over possession.
