It has come to my notice that interest u/s. 23(1-A) of LA Act awarded as compensation for land measuring 306 bigha 02 biswa acquired in village Malik Pur Kohi alias Rangpuri vide award No.1/98-99/SW has been wrongly assessed as Rs.1,85,91,434.86 whereas it should have been Rs.55,12,197.38 in view of the stay, granted by the Hon'ble High Court of Delhi period w.e.f. 18.1.1996 to 31.3.1998 i.e. 802 days. Inadvertantly the interest u/s.23(1-A) of LA Act was assessed for the stay period also. Now involving the powers conferred on me vide section 13(A)(1) of the Land Acquisition Act, 1894. I hereby assess the interest u/s.23(1-A) of the LA Act as Rs.55,12,197.38.

A notification under section 4 of the Land Acquisition Act 1894 was issued vide notification No. F9(12)/95-L&B/LA/8388 dtd. 1.6.1995 for an area measuring 306 bigha 02 biswa in the village Malik Pur Kohi alias Rangpuri. The land was required to be taken by Govt. at Public expense for public purpose, namely construction of staff quarter for Govt. of NCT of Delhi, under the Planned development of Delhi.

In pursuance of the above notification U/s 4, it has been cleared that the provision of Section 5(A) shall not apply. It is followed by notification U/s 6 of even No. F.9(12).95-L&B/LA/8438 dtd. 16.11.95 and U/s 17(1) of even No. F.9(12)/95-L&B/LA/8440 dtd. 16.11.95.

Notices U/s 9 & 10 of LA Act 1894 were issued to the persons interested which will be described under appropriate heading.

MEASUREMENT AND AREA

Necessary demarcation was carried out on the spot in the presence of field staff from Land and Building Deptt., PWD Deptt. and LAC (V.V.). The area notified was 306 bigha 02 biswa but as per field book and Revenue Record the total area comes to 306 bigha 04 biswa. The details of the area acquired are as under:-

MARKET VALUE :

In a policy announcement which came into effect from 1.4.97 vide notification No. F.9(20)/80/L&B/LA/6641-85 dtd. 30.6.97 and F.9(20)/80/L&B/LA/8822-66 dtd. 25.7.97, the Govt. of Delhi has fixed the indicative price of agriculture land @ Rs. 10/- lacs per acre. But as per notification No. F.9(20)/80/L&B/LA/8822-66 dtd. 25.7.97 the land rate comes to Rs. 7,77,853.10 per acre. At the time of issuing the notification U/s. 4,6 & 17(1) the land rate fixed by the Govt. of Delhi was 4,65,000/- per acre. But keeping in view the notification dtd. 25.7.97 issued by Govt. of Delhi I accordingly determined the market value of the land under acquisition @ Rs. 7,77,853.10 per acre. In addition to the market value, the land owners will be entitled to all other benefits as per provision of the LA Act.

SOLATIUM :

30% Solatium will be given to the interested persons due to compulsory nature of acquisition.

APORTIONMENT :

Compensation of the acquired land will be given as per latest entries in the revenue record except where person other than owners claims compensation found any kind of dispute. In case of dispute the matter will be referred to the court of A.D.J. U/s 30-31 of the LA Act of 1894.

LAND REVENUE:

The land under acquisition is assessed for sum of Rs. as land revenue. Hence, the same will be deducted from the rent roll of the village with effect from date of taking over the physical possession of the
