These are proceedings for determination of compensation Under Section 11 of the Land Acquisition Act 1894 and L.A. (Amended) Act 1984 for an area measuring 1337 -04 (Bigha - Biswa) situated at Village Malikpur Kohi alias Rangpuri, Tehsil Vasant Vihar, Delhi. The land under acquisition was notified U/S 4, 6 & 17(1) vide notification Nos. F9(12)/95/L&B/LA/9743, Dt. 27.6.96 and F9(12)/95/L&B/LA/1046, Dt. 10.1.1997 respectively. The land is required by the Government for a public purpose namely for the planned Development of Delhi, Development of Vasant Kunj, Phase IV at public expense.

Notices U/S 9 & 10 were issued to the interested persons of Village Malikpur Kohi alias Rangpuri, Delhi to file their claims. The claims filed by the interested persons will be discussed under the heading 'Claims'.

True and Correct area

The land was measured on the spot in the presence of field staff, The area notified was 1337-04 (Bigha-Biswa) but as per field book and revenue record the total area comes to 1333 Bigha and 10 biswa. The details are as under :-

MARKET VALUE

In a policy announcement which comes into effect from 01-4-1997 vide Notification No. F9(20)/80/L&B/LA/16641-85, Dt. 30.6.97 and No. F9(20)/80/L&B/LA/822-66, Dt. 25.7.1997, the Govt. of Delhi has fixed the indicative price of agriculture land @ Rs. 10 lac per acre. But as per notification No. F9(20)/80/L&B/LA/822-66, Dt. 25.7.1997, the land rates comes to Rs. 9,12,095.90 per acre instead of Rs. 10,00,000/- per acre which states as under :-

"The indicative price of agriculture land would apply to all such cases where land has been notified U/S-4 of the Land Acquisition Act before 01.4.1997 and awards have not been announced as yet. In such cases the indicative price of Rs. 10 lac per acre may be discounted @ 11.5 % per annum compounded rate of interest".

At the time of issuing the notification U/S - 4 & 6, the land rate fixed by the Govt. of Delhi was Rs. 4,65,000/- per acre. But keeping in view the notification No. F9(20)/80/L&B/LA/8822-66, Dt. 25.7.97 issued by Govt. of Delhi, I accordingly determined the market value of the land under acquisition @ Rs. 9,12,095.90 per acre or Rs. 1,90,020/- per bigha. In addition to the market value, the land owners will be entitled to all other benefits as per provision of the land acquisition act.

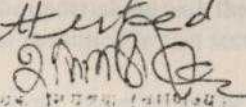

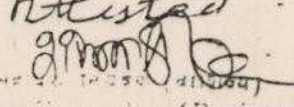
