PURPOSE OF ACQUISITION : Forward Bund upstream of Wazirabad Barrage.

INTRODUCTION

These are the proceedings u/s 11 of the Land Acquisition Act, 1894 for determination of compensation in respect of land measuring 75 bigha 13 biswa in Village Sabhapur. The land is required for Forward Bund upstream of Wazirabad Barrage. It stands notified u/ss 4, 6 & 17 of the Land Acquisition Act, vide notification No. F. 7(40)/75-L&B(i)(ii)(iii) dated 30.9.1976.

This being ~~case~~ of emergency, section 17 of the said Act was also made applicable vide notification No. F.7(40)/75-L&B(3) dated 30.9.1976 and possession of the land was taken ~~on~~ by 23.3.78.

Notices u/s 9 & 10 of the L.A. Act were issued to the persons interested for filing their claims. Claims filed have been kept in record and will be discussed later under a separate heading "Claims & Evidence."

CORRECT AREA & MEASUREMENT

Physical verification and measurement of the land was carried out by the Revenue Field Staff as required under section 8 of the Act and as per the demarcation given and measurement carried out, the area required for the scheme was found to be 75 bigha 13 biswas which is correct, details of which are as under:-

Although the interested persons have filed their claims and demanded exorbitant rate for the land which varies between Rs. 10,000/- to Rs. 11,000/- per bigha but no documentary proof has been furnished with their claims.

MARKET VALUE

The market value of the land is to be determined with reference to the price prevailing at the time of date of preliminary notification u/s 4 & 6 of the L.A. Act which in this case is 30.9.1976. While assessing the market price, various factors, like size, shape, situation, its tenure, the use to which it is put, its potentiality and also the rise and fall in the demand of the land are to be taken into consideration. The best and proper guidance in this behalf can be taken from the genuine sale transactions took place on or about the time of preliminary notification either in respect of the land under acquisition or part thereof or the sale of the land parallel in circumstances to the land under acquisition. Accordingly the Revenue field staff searched for the same.

As regards sale transactions no such transaction has been reported by the Field Staff. However, one Shri Ram Parkash Singh s/o Shri Ram Bilas Singh r/o Qr.No. 5, Wazirabad, Delhi has produced a copy of sale deed for a plot of 100 sq.yds of April, 1973 and the consideration money is Rs. 12,000/- This sale deed is in respect of land situated in Village Biharipur and on the basis of this document land would cost Rs. 12,000/- per bigha. Since the transaction is of a small plot of 100 sq.yds principle only as such this document cannot be taken as a guiding principle in this case.

In the past there have been some Awards in Village Biharipur and the latest Award is 15/83-84 in which the land has been assessed at Rs. 3500/- per bigha. Both the Villages namely Baqiyabad and Sabhapur Patti Chauhan are close to village Biharipur as such the Award announced in respect of this village is considered to be more suitable. On the basis of the aforesaid Award, case of Village Baqiyabad was decided and the market value of land awarded in that village is Rs. 6000/- per bigha. Since Village Sabhapur, Patti Chauhan is nearer to Baqiyabad and is similarly circumstances, as such the land of this village under acquisition is also assessed at Rs. 6000/- per bigha which is fair, just and justified.

SOLATIUM

15 % solatium over and above the market value of the land will be paid towards compulsory nature of acquisition.

POSSESSION

Possession of 75 bigha 13 biswa of land was taken over on 23.3.1978 u/s 17 of the Land Acquisition Act. The persons interested are entitled to interest at the rate of 6% p.a. from the date of possession till the date of tender of payment.

APPORTTOMMENT

Payment will be made according to the latest entries in the revenue record. In case of dispute which is not settled within a reasonable time amicably the amount of compensation will be remitted to the Court u/s 30-31 L.A. Act for adjudication of title.

LAND REVENUE.

The land under acquisition is assessed to Rs. 16-03 paisa as land revenue which will be deducted from the Khalsa Rent Roll.
