NAME OF VILLAGE : SABHAPUR
NATURE OF ACQUISITION : PERMANENT
PURPOSE OF ACQUISITION : Alternative path connecting
S.M. Bundh to Left Forward Bundh.

These are the proceedings u/s 11 of the Land Acquisition Act, 1894 for determination of compensation in respect of land measuring 10 bighas 13 biswas in Village Sabhapur. The land is required ^{by Govt. at public expense for a public purpose namely} for alternative path connecting S.M. Bundh to Left Forward Bundh. It is notified u/s 4, 6 & 17 of the Land Acquisition Act vide notification No. F.7(17)/82-L&B(i)(ii)(iii)/47057 dated 23.12.1982. Total notified area is 10 bigha 13 biswas. Since it was a case of emergency as such section 17 of the Act was also operative in this case and a notification No. F.7(17)/82-L&B dated 23.12.82 was issued and possession of the land was taken on 18.7.83.

Notices u/s 9 & 10 of the L.A. Act were issued to the persons interested for filing their claims. Claims filed in the case have been placed on record and will be discussed later under heading "Claims & Evidence."

CORRECT AREA & MEASUREMENT

The Land Acquisition Field Staff carried out necessary measurement on the spot alongwith the field staff of the acquiring department as per the requirements of the provisions of law. As per the demarcation given and measurement carried out of the area actually required for the scheme was found to be 10 bighas 13 biswas as notified. The details of the land are given as below :-

MARKET VALUE

The market value of the land is to be determined with reference to the price prevailing at the time of date of preliminary Notification u/s 4 of the L.A. Act which in this case is 23.12.82. The best and proper guidance in this behalf can be taken from the genuine sale transactions took place about the time of preliminary notification either in respect of the land under acquisition or part thereof or the sale of the land parallel in circumstances to the land under acquisition. Apart from this, help can also be derived from awards already drawn and announced in this area. No sale transactions available which have been effected in the area at the time of date of preliminary notification u/s 4 of the L.A. Act. The claimants have claimed Rs. 50,000/- per bigha but no supporting evidence has been produced. Award No. 11/84-85 has been announced in this Village.

The award made in respect of this very Village on 11.6.84 @ Rs. 6000/- per bigha can give sufficient guidance as to the determination of the market value. This award

was the result of Notification No.F.7(40)/75-L&B(1) dated 30.9.76 while the present award pertains to the notification No.F.7(1)/82-L&B(i)(ii)(iii)/47057 dated 23.12.82. In view of the time gap, I feel that market value of Rs. 7000/- per bigha is quite reasonable under the circumstances & I assess the same accordingly.
