Market Value:

The land through this offer is temporarily acquired for a period of one year u/s 35(1) of the Land Acquisition Act, 1894 for placing and digging out earth for the work of Keshopur

effluent irrigation scheme on the left hand of Najafgarh drain. This village comes under the purview of the Delhi Land Reforms Act, 1954 and under this Act sub-letting is not enjeyed as section 35 of the Land Acquisition Act lays down that apart from disabled persons and bhumidhari or assami shall implet for any period whatsoever any land comprised in his holding. That being so it is not possible to get any mutation by way of lease-hold rights executed for the temperary occupation of the land. Local enquiries have revealed that no sub-letting has been made in this village.

There are only two sale transactions pertaining to th year 1971. The sale transaction No.4238 took place on 29-4-71. The land in question is in the abadi. As such, this sale has to be discarded. The other sale deed number is 9647. It was executed on 17-8-71. A number of khasra numbers were sold. The area is 18-05 bighas and the avera per bigha works out to Rs. 1041.09P. A perusal of the sale deed shows that gitwar comprising of khasra No.98 was also sold through the said sale deed in question. In the villa two awards have been made. In award No.32/1970-71, the Land Acquisition Collector awarded R. 800/- for block 'A' which comprised of Abpash and Gair Abpash land and Rs. 500/for block 'B' which comprised of Banjer Jadid and Banjer Qadim. The date of preliminary notification is 6-9-69. T preliminary notification of the other award No.1838 is Under , as O + recor the ver fee why propries be 6-6-64. This has no relevance and is discarded. The annu rent for the land under acquisition is award No.32/70-71. As stated earlier there is no evidence that the land has been sub-let and as such it is not possible to ascertain the fair annual rental payable to the owner as yearly rent for the temporary occupation. In the absence of any such positive evidence there is no other method except to pay

6% on the market value of the land so fixed as yearly rent of the land under temporary acquisition for a period of one year. Calculated at this rate the annual rent of the land is fixed at R.48/- per bigha. The time between the material date and the present award is 2 years 4 months. I consider a little change in the price of land is reasona and fix R.54/- per bigha kham as yearly rent for the land under temporary acquisition for a period of one year. No rent will be paid for khasra No.62/2/1 and 62/3/1 as they are public thoroughfare.

Trees, Wells and Structures:

There are no trees, wells and structures on the land under acquisition.

Apportionment:

Compensation will be paid according to the latest entries in the revenue record.
