These are the supplementary proceedings of Award No. Nax 5 5/83-84 which was announced on 21.5.83. The land in this case was notified u/s 4 vide notifiation No.F.7(52)/81-L&B(4) dated 24.5.82 The total area acquired in this award was 2 bighas 05 biswas.

After the announcement of the above award, Landacquisition Act, 1894 has been amended and the amendment Act came into force w.e.f. 24.9.84. However, as per provision of section 30 of the Land Acquisition (Amendment) Act, 1984, certain provisions of the Act are to take effect from 30.4.82. Jence, the need for the supplementary award has arisen.

Under the Amended Act, the provisions of section 23(1) have been amended by providing a new sub-section(1(A)) of section 25 of the Principal Act as inserted by clause A of section 15 of the Amended Act. By this amendment, the interested persons will get an amount calculated @ 12% p.a. on the market value for the period commencing on and from the date of publication of the notification u/s 4 till the date of the award of the Collector or date of taking over possession of the Land whichever is carlier. Similarly, section 23(2) of the Principal Act has been amended by clause A of section 15(%) of the Amendment Act by which the interested persons will be entitled solatium @ 30% instead of 15%. All these amendments are to take effect from 30.4.82 as per provisions of section 30 of the Amendment Act, 1984.

Reeping in view the provisions of the Amended Act, the interested persons/bhumidars of a word No.5/83-84 which was announced on 21.5.83 are entitled for payment of solstium @ 30%
