### INTRODUCTION

These are proceedings for determination of compensation u/s 11 of the Land Acquisition Act, 1894 in respect of the land measuring 1 bigha 15 biswas situated at village Tikri Kala notified u/s 4 of the Land Acquisition Act vide notification F.7(44)/81-L&B/(I) dated 12-2-87 for a public purpose; namely for construction "Check Barrier at Tikri Border NH 10" In view of the urgency of the scheme the provisions of Section 17(1) of the Act were also made applicable to this land. Delhi Administration issued a declaration u/s 6 of the L.A. Act vide notification No.F.7(44)/81-L&B (2) dated 26-2-87.

In pursuance of the above rexienties notification u/s 6, notices u/s 9 & 10 of L.A.Act were issued to all the interested persons to file their claims and the claims filed by the claimants are discussed here-in after under the heading "Claims".

### MEASUREMENT

The area to be acquired as given in the declaration u/s 6 is 1 bigha 15 biswas, which is found correct at the time of measurment by the field staff. The details of the land under acquisition are as under:

Moreover the claimants have not raised any objection regarding the measurement and classification of the land based on the latest entries in the revenue records. CLAIMS

He raised objection regarding the acquisition and state that in case No. 1784/ 87 and 2498/87 there is a stay of High Court.

MARKET VALUE The market value of the land is to be determined after keeping in view the situation, advantages and potentialities attached to the land on the date of notification under section 4 of L.A.Act. The land usem is also to play an important role in deciding the market value of the land. It has been seen that the provisions of Delhi Land Reforms Act are applicable and thus restrictions contemplated under sec. 22 & 23 of the Delhi Land Reforms Act are also applicable and the land can only be used for agricultural, horticulture er animal, husbandary.

None of the interested persons have claimed any compensation under the provisions of Sec. 9 & 10 of the Land acquisition Act and as such I proceed to assess the market value of the land in question on best of judgement. The field staff was directed to consult the revenue records and also to intimate the list of sale deeds which have been executed in this village just before the period of notification u/s 4 of the L.A.Act issued on 12-2-87. The details of the sale deeds are as under:

Perusal of the sale deeds reveals that there is wide difference in the rates of land between the short period of 6 months. The lowest rate is only Rs. 895.52 per bigha whereas maximum rate comes to Rs. 38, 400 P.B. The transactions involved in the said sale deeds donot reflect true, picture of the market value of the agricultural land.

The following 3 awards have been announced in this village which are also discussed to povice at the market value of the land in question:

These awards relate to the material dates 10-1-80, 26-11-1981 and 18-3-85. Perusal of award No. 45/82-83 shows that the L.A.C. have awarded the rate of compensation at Rs. 3500/per bigha and it was enhanced by the A.D.J. in LAC case No. 240/83 Nawal Singh vs. U.O.I. & Rs.16,000/- per bigha. However, in this case appeal was beenex filed in the High of Delhi over and above the amount of Rs. 8, 750/-. The main reason for not accepting the enhancement made by the A.D.J. as per opinion of the Deputy Legal Advisor was that there were wide wariation4 in the rates of the land in the sale deeds which were made on the basis of enhancement by the A.D.J. In Award No.23/85-86 of this village, L.A.C. has determined the market value @ks.14,000/- per bigha and the date of notification u/s 4, in this case was issued on 18-3-85.

Further scrutiny and updating the market value of the land as per appeal referred in case No. LAC 240/83 Nawal Singh v/s U.O.I. against award No. 45/82-83 and updating of the market value of the land as determined by the L.A.C. in award No. 23/85-86, the market value calculates to Rs.12,858/and Rs. 16, 440-60 respectively. Since there is no decision on the appeal case No. LAC 240/83 of Nawal Singh ys. U.O.I. as yet, it would not be proper to assess the market value based on im award No. 45/82-83 because the updated market value in award No. 23/85-86 works out to Rs.16,440.60 per pigha. This piece of land is otherwise also inclose proximity to the land as per award No. 23/85-86 announced on 18-3-85. I, therefore, assess the market value of the land @Rs. 16, 440/per bigha for agricultural land bearing kh.No. 31/33 (1 bigha). The land measuring 4 bigmas and 0-11 biswas in Kh. No. 1377/2 min and 1384 min. are gair mumkin rasta and belonging to Gaon Sabha, no compensation is allowed. The Pradhan, Gaon Sabha has given in writing against the claims filed under sec. 9 & 10 of the L.A.Act. The market value is thus determined accordingly. SOLATIUM:

As provided under sub-sec. 2 of section 23 of D. Act, the interested persons will be paid 30% solation the market value of the land due to compulsory nature of acquisition as per provisions of the Land Acquisition (amendment) Act, 1984.
