New Initiative

1. People can lodge their grievances on various online public grievances redressal portal like PGMS, LG Listening Portal and CP GRAMS Public Grievances are required to be resolved within 15 Days in case of PGMS and LG Listening Portal and 45 days in case of CP Gramm.
2. People can also lodge Pollution related Grievances on Green Delhi mobile app/Web Page.
3. Online Registration of Firms and Society has also been available on (<https://firmsociety.delhi.gov.in/fsmis/AboutUs.aspx>).
4. Revenue Department is also implementing Mukhya Mantri Parivar Aarhik Sahayata Yojana with way.
5. Govt. Of NCT has already achieved more than 100% Aadhar saturation as on 15/08/2021 Aadhar saturation stood at 107.15% and ranked first among all States/UT's.
6. Deptt. Of Revenue GNCTD is also implementing Sakhi-One Stop Centre scheme in all 11 Revenue Districts with the help of Deptt. of women and Child Development, GNCTD. It is aimed at helping woman who suffered violence with Psycho-Social Counselling, legal aid facility.
7. Deptt. Of Revenue, GNCTD is in the process of rejuvenating 36 water bodies with the help of DJB and DDA.
8. At present there are 317 Urbanised Villages in Delhi while 49 Rural Villages are Administered by Directorate of Panchayat, GNCTD through its BDOs.
9. As on 10/08/2021 29472 CDVs were engaged to carry out various activities.
10. Exclusive vaccination centres have been established in each Revenue Districts for vaccination of persons with disabilities.
11. Seven Services being currently provided by Deptt. Of Revenue are also available on Umang Mobile App.
12. All Revenue Districts have prepared District Environment Plan (DEP) and are in the process implementing the same.
13. Till date 9385 borewell have been closed down out of 19661 as per the Order of NGT in O.A. 25/2019.
14. Till Date 1674 borewell have been closed down in various parks of Delhi as per the Order of NGT in O.A. 6/2012.
15. Court Cases are continuously being monitored through e-Litigation Portal.
