Brief gist of the Acts implement by this Department

- φ **The Child Labour (Prohibition & Regulation) Act, 1986**
An act to prohibit the engagement of children in certain employments and to regulate the conditions of work of children in certain other employments.
- φ **The Notaries Act, 1952**
An act to regulate the profession of notaries
- φ **The Air (Prevention & Control of Pollution) Act, 1981**
An Act to provide for the prevention, control and abatement of air pollution, for the establishment, with a view to carrying out the aforesaid purposes, of Boards, for conferring on and assigning to such Boards powers and functions relating thereto and for matters connected therewith.
- φ **The Indian Electricity Act, 1910**
An act to amend the law retaining to the supply and use of electrical energy
- φ **The Cable Television Networks (Regulation) Act, 1995**
Promulgated by the President in the Forty-fifth Year of the Republic of India. An Act to regulate the operation of cable television networks in the country and for matter connected therewith or incidental thereto.
- φ **The Motor Vehicles Act, 1988**
An act to consolidate and amend the law relating to motor vehicles
- φ **Revenue Recovery Act, 1890**
An Act to make better provision for recovering for recovering certain public demands
- φ **The Special Marriage Act, 1954**
An Act to provide a special form of marriage in certain cases, for registration of such and certain other marriages and for divorce.
- φ **The Delhi Land Revenue Act, 1954**
An Act to consolidate and amend the law relating to land revenue and jurisdiction of Revenue Officers in the State of Delhi
- φ **The Registration Act, 1908**
An Act to consolidate the enactment relating to the Registration of Documents
- φ **The Indian Forest Act, 1927**
An act to consolidate the law relating to forest, the transit of forest-produce and the duty leviable on timber and other forest-produce.
- φ **The Hindu Marriage Act, 1955**
An Act to amend and codify the law relating to marriage among Hindus
- φ **The Delhi Land Revenue Act, 1954**
An Act to consolidate and amend the law relating to land revenue and the jurisdiction of Revenue Officers in the State of Delhi
- φ **Bonded Labour System (Abolition) Act, 1976**
An Act to provide for the abolition of bonded labour system with a view to preventing the economic and physical exploitation of the weaker sections of the people and for matters connected therewith or incidental thereto.

- φ **The Indian Stamp Act, 1899**
An Act to consolidate and amend the law relating to Stamps
- φ **The Land Reforms Act, 1954**
An Act to provide for modification of zamindari system so as to create an uniform body of peasant proprietors without intermediaries, for the unification of the Punjab and Agra system of tenancy laws in force in the state of Delhi and to make provision for other matters connected therewith.
- φ **The National Trust Act, 1999**
An act to provide for the constitution of a body at the National level for the welfare of persons with Autism, Cerebral Palsy, Mental Retardation and Multiple Disabilities and for matters connected therewith or incidental thereto.
- φ **The code of Criminal procedure, 1973**
An Act to consolidate and amend the law relating to Criminal Procedure
- φ **Mine & Mineral Act, (Development & Regulation) Act, 1957**
An act to provide for the development & regulation of mines & minerals under the control of Union
- φ **Noise Pollution (Regulation & Control) Rules, 2000**
For enforcement of Noise Pollution & for compliance of ambient air quality standards in noise & noise in any area shall not exceed these standard as given in scheduled
- φ **The Scheduled Caste and scheduled Tribes (Prevention of atrocities Act) 1989**
An Act to prevent the commission of offences of atrocities against the members of Scheduled castes & the Scheduled Tribes, to provide for special court for the trial of such offences & for relief & rehabilitation of victims of such offences & for matters connected there with or incidental thereto.
- φ **The person with disability Act 1954**
An Act to give effect to the proclamation on the full partition & equality to people with disability in Asian & Pacific region. This act provides equal opportunity, protection of rights & full participation to persons with disability.
- φ **The Public Liability Insurance Act, 1991**
An Act to provide for the development & regulation of mines & minerals under the control of Union.
- φ **Prevention of Food Adulteration Act**
An Act for the prevention of adulteration of food
- φ **Delhi degradable Plastic bag (Manufacture, Sales & Usages) and Garbage (Control) Act, 2000**
This is for protection of environment & to keep away pollution
