

Minority Cell Report

1. Establishment of Minority Welfare Cell in the Month of November/ December 2018 to fulfill the aims and objective of improving socio-economic conditions of Minority under PMJVK.
2. Need based Proposals were finalized focused on holistic development of Minority Communities. 80% of the resources under Pradhan Mantri Jan Vikas Karyakram (PMJVK) were proposed for project related to Education, Health and Skill. 40% of the resources earmarked for creation of assistance or facilities for Women and Girls.
 - a) Establishment of Multipurpose Community Centre in Delhi.
 - b) Installation of Eco-friendly sanitary Napkin Incinerator in school of Directorate of Education.
 - c) Integrated Child Development Programme (Anganwadi).
 - d) Free Coaching facility.
 - e) Opening of Residential School.
 - f) Exchange Cultural Programme under Ek Bharat Shreshtha Bharat (EBSB).
 - g) Adventures Programme through The Bharat Scout and Guide (BS & G) & National Adventure Institutes (NAI).
 - h) To explore the possibility of loans for self employment.
 - i) Construction of Hostel for Students of Minority.
 - j) Research Study related to Migrated /Minority Communities settled North East, Central and South East Delhi engaged informal sectors.
3. Nomination of Mr. Sanjay Singh, Member of Rajya Sabha, M.P. was forwarded in the month of December, 21st, 2019 and it was received on 27/02/2019 and Mr. Sanjay Singh has been now included as the Member of State Level Committee and District Level Committee and very soon state level committee will be held to finalize the proposals of PMJVK. Further, it will be send to EC in MoMA for recommendation and approval of the project.
4. Detail Project Reports for six proposals of PMJVK have been prepared to be placed before SLC with estimated cost price is Rs.780.40 in lacs (Central Share :- Rs.468.24 lacs and State Share:- Rs.312.16 lacs).
5. State Level Committee has been formed for implementation of PM New 15 Point Programme for the welfare of minority headed by CS and all the department concerns Secretaries of Finance, Planning and Member Secretary have been included.
6. Haj House construction:- The matter was speedily taken up with PWD, DDA and pending issues have been resolved paving way for speedy movement for Construction of Haj

House.

- a) Haj House Construction file was moved in 2008 and for ten years there was no movement or processing of the programme but in 2019 the speedy action under the guidance of Divisional Commissioner/ Pr. Secretary (Revenue) has taken a new height.
7. Delhi State Haj Committee Reconstitution:- The file was effectively dealt with and as per the Rules and Acts of Delhi State Haj Committee. Reconstitution of Haj Committee was proposed taking care of eligible nominations with expertise in their fields were nominated and forwarded for recommendation to the Competent Authority.
8. Regarding issuing of minority scholarship in respect of Centrally Sponsored Schemes (CSS) under Scheme i.e. implementation of three Scholarships for Minority i.e. Pre-Matric, Post-Matric and Merit-cum-Means based scholarship schemes heading are being taken up effectively so that all the grants are able to reach the needy persons.
9. Prompt actions are being taken for release of payment in respect of physically challenged and widows section of minorities.
10. The proposal for enhancement of Imams and Moazzins have been taken place but still approval of the Competent Authority is awaited for the release of payment.
11. Under Seekho Aur Kamao, a letter was sent to MoMA bringing in factual position of PIA in Delhi inspection report was send on 18-02-2019 has directed to conduct an enquiry regarding the functioning and authentic services provided by various centres of Project Implementation Agencies. The same were 'expected and lot of aberrations were focused and intimated to the Director of MoMA under the Scheme Seekho Aur Kamao.
12. Waqf Board Tribunal has been formed and notification has been issued on 30-03-2019.
