ategory (A)

Private land i.e. land owned by the private individuals.

The registration of instruments of sale and transfer of properties in this category will be allowed as per laid down procedure and formalities under the Registration Act, 1908 and other applicable laws.

Category (B)

The notified land i.e. the land notified for acquisition under the Lands Acquisition Act, 1894 but where no awards have been made by the Collector resulting in lapse of acquisition proceedings under section 11A of The Land Acquisition Act, 1894.

Category (C)

Awarded land i.e. all such land which has been notified for acquisition under The Land Acquisition Act, 1894 and the award with respect to the same has also been made by the Collector. However, the possession of such land has not yet been taken over and compensation has not been paid.

In respect of category (B) and (C) lands above , the registration of instruments of sale and transfer of properties will be allowed after withdrawal of notification issued for acquisition or de-notification of land under section 48 of The Land Acquisition Act, 1894, as the case may

Category (D)

Vested Gaon Sabha land i.e. the land vested with the Gaon Sabha under section 81 of the Delhi Land Reforms Act but where physical possession is with private owners or their successor-in-interest.

The registration of instruments of sale and transfer of properties in this category will be allowed after required amendments in the revenue records as per law by the Revenue Department.
