**ORDER**


Consequent upon implementation of E-Stamping and issue of E-Stamp instead of NJSP in respect of chargeability of stamp duty under different articles of schedule IA of Indian Stamp Act, 1899 on various instruments executed with regard to conveyance/transfer etc. of movable/immovable properties, the work relating to refund of unused E-stamped certificate issued by SHCIL, will only be dealt centrally in Stamp Branch in the office of the Chief Controlling Revenue Authority/Divisional Commissioner Office, 5 Sham Nath Marg, Delhi-110054.

In this regard below mentioned Officers are hereby designated as Nodal Officer to allow the refund of unused/spoiled E-Stamp Certificates in the Office of the Chief Controlling Revenue Authority, 5 Sham Nath Marg, Delhi:-

1. Collector of Stamps (HQ)/SDM(HQ-I)
2. During the absence of Collector of Stamps(HQ)/SDM (HQ-I), his link officer SDM (HQ-II)/Collector of Stamps(HQ). Collector of Stamps (HQ)/SDM (HQ-II) shall not ordinarily perform the functions of Collector of Stamps(HQ) for the purpose of refunds as specified above.  
(Both appointed as Collector of Stamps vide Notification F.No.2(21)/95-Fin.(G)/2263 dated 18.3.1998 by Finance General Department, Govt. of NCT of Delhi and are empowered to allow the refund with in the provisions of section 49, 50, 52 and 54 of the Indian Stamp Act, 1899)
3. Dy. Commissioner(North) who is performing the duty of Dy. Commissioner(HQ) is empowered to allow refund up to two years.

And the cases of refund beyond two years shall be referred to Hon'ble L.G., Delhi.

This issue with the prior approval of C.C.R.A./Divisional Commissioner, Delhi.
