ORDER

This order shall dispose off the appeal received in this office on 01.08.2022. w.r.t. RTI ID No. 25524.

Hearing notice was issued for appearance on 23.09.2022 at 02.00 PM.

On the date of hearing i.e. 23.09.2022, following were present :

1. Sh. Sh. Ajit Kumar, Appellant present in person.
2. Sh. Atul Kr. Jain, Section Officer from the office of PIO / SDM (Treasury Branch), Revenue Deptt. (HQ).

The applicant had filed an RTI dated 27.06.2022 seeking information regarding date of availability of Non Judicial Stamp Papers of denominations of Rs. 2/- and Rs. 10/- to the public for sale in Delhi and India. It was also asked vide the said RTI the color of Non Judicial Stamp Papers of denomination of Rs. 2/- and Rs. 10/- in the year 1978, 1985 and 1990. The said RTI application was transferred to PIO / SDM (Stamp & Regn. Branch / Treasury Branch), Revenue Department (HQ) vide letter dated 06.07.2022.

The matter was heard on 23.09.2022. Sh. Atul Kr. Jain, Section Officer from the office of PIO / SDM (Treasury Branch), Revenue Deptt. (HQ) informed that the reply to the above mentioned RTI was issued vide office letter dated 29.07.2022. He also informed that the information sought in point No. 5 and 6 through the RTI does not pertain to their department and the same has been forwarded to the concerned department i.e. India Security Press, Nashik, Maharashtra. Sh. Ajit Kumar stated that till the date of filing an appeal, he had not received the reply. However, a copy of the reply dated 29.07.2022 was handed over to the appellant. Sh. Ajit Kumar, Appellant was satisfied with the reply as provided by the PIO.

In view of the above, the appeal stands disposed off and ordered accordingly.

The applicant had filed an RTI dated 24.01.2022 seeking information regarding demarcation of government land at Azadpur, G.T. Road, in front of M2K Victoria Garden. The said RTI was transferred from Revenue Department (HQ) to PIO/SDM (Model Town) Distt. North vide letter dated 03.02.2022.
