The applicant has filed an application dated 14/12/2017 seeking information regarding selection of Civil Defence Volunteers in DC (East) office etc. The applicant originally filed the RTI application in Home Guard on 14/12/2017 wrongly marked to SDM (HQ) and it has finally reached to PIO (Civil Defence). There is no mechanism is placed in the office of Civil Defence for computerized online receipt of the application which is leading to the application reaching him by indirect route which is leading to delay. SSO (Civil Defence) is directed to ensure that such mechanism is place in his office within 10 days positively. SSO (Civil Defence) will obtain the information from the concerned PIO and provide the information to the applicant within two weeks positively without any charges in terms of the provision of RTI Act, 2005.
5. Ordered accordingly.

If you are not satisfied with the information provided, you may file an appeal before Central Informaton Commission, August Kranti Bhawan, Bhikaji Cama Place, New Delhi-110066 within the stipulated time.
