

ORDER

This order shall dispose of the appeal filed by Shri Ramji Yadav in respect of I.D.No. 17082.

1. Present Shri Ramji Yadav, appellant on 16/08/2017.
2. Present Shri C.S. Yadav, SDM - VIII (HQ).
3. All present heard.
4. The applicant has filed an application dated 11.5.2017 seeking a series of information regarding the details of marriages conducted between January, 1971 to December, 1971. The SPIO/SDM-VIII has given a point wise reply to the applicant. However, the reply in respect of point No.1 has not been given by the GA branch. I tend to agree with the applicant that the reply in respect of point No.4 should be given in a more detailed manner. The SPIO/SDM-VIII is required to give a reply in respect of point No.5 within a period of 10 days. The applicant states that the reply in respect of point No.3 is not correct. I tend to agree with the contention of the SPIO/SDM-VIII that the information comes within the purview of section 8(j) of the RTI Act, as such the same cannot be provided. The application is disposed of with these remarks.
5. Ordered accordingly.




