ORDER

This order shall dispose of the appeal filed by Shri Mayank Dayal in respect of I.D.No. 17551.

1. Present Shri Mayank Dayal, appellant on 11/10/2017.
2. Present Shri Dinesh Jha, SDM - VI (HQ).
3. All present heard.

4. The applicant has filed an application dated 31/07/2017 seeking a series of information related to attestation of documents. The SPIO/SDM-VI (HQ) has given the reply on 08/09/2017. The SPIO states that in view of the insufficient details provided by the applicant point wise reply could not be provided to the applicant. The applicant has merely provided a certificate number and date. The SPIO further states that the same is actually the number of a stamp paper on which the document was prepared and the copy of which was not enclosed by the applicant while filing the RTI application. The applicant states that he has subsequently provided the details. I also tend to agree that most of the information relevant to the 3rd party was provided u/s 11 of the RTI. The applicant in his application has stated that the information does not fall within the restrictions contained u/s 8 and 9 of the RTI Act. However, the SPIO states that the information falls within the restriction u/s 11 of the Act.

The application is in the nature of a complaint for which a separate remedy is available to the applicant and he may pursue the same. The application is disposed off with these remarks.

5. Ordered accordingly.

If you are not satisfied with the information provided, you may file an appeal before Central Information Commission, August Kranti Bhawan, Bhikaji Cama Place, New Delhi-110066 within the stipulated time.
