**ORDER**

This order shall dispose of the appeal filed by Shri Laik Ahmed in respect of I.D.No. 17451.

4. The applicant has filed an application dated 11/07/2017 seeking a series of information regarding the transfer/posting of Patwaris/Kanungos. The SPIO/SDM-VI (HQ) has given a point wise reply to the applicant. As regards the details which are available in different files, the SPIO is directed to allow the inspection of the record to the applicant on 16/10/2017 at 3.00 PM as mutually agreed between SPIO and the applicant. The applicant is directed to visit the office of SPIO on the above said date and time to inspect the report and take relevant extract after due payment as required under RTI Act. The SPIO has given the information in respect of point No. 4. However, if the information did not pertain to his office, the SPIO should have forwarded the same to the concerned branch for providing the information. The applicant has filed the application on 11/07/2017 and the reply was given to him of 09/08/2017. In view of the same, I do not find merit in the contention of the applicant that the reply has been given late after 42 days. The application is disposed off accordingly.
