**ORDER**

This order shall dispose off the appeal filed by Mrs. Sudha Vohra in respect of I.D.No.21974 & 22034.

1. Present : Mr. Avinash Chander Vohra, on behalf of Appellant with authority.
2. Present : Sh. Atul Kumar Jain, ASO, Treasury Branch on behalf of SDM (HQ).
3. All present heard.
4. The Applicant has filed an RTI application on 20.11.2019 regarding information of Non-judicial stamp paper No.00AA643108. The appellant mentions that the issue of revenue stamp i.e. in RTI ID-22034 is not an issue and he is satisfied. With regard to another RTI-21974 he states that he wants as to when & to whom the stamp paper no.00AA643108 was issued by the treasury. Sh. Atul Kumar, ASO/APIO states that though papers were numbered but records with paper nos. issued was not kept vendor wise since Feb. 2005 and stated only later on - It was commenced meticulously. The APIO Sh. Atul Kumar Jain, ASO mentions that he has no record of as to whom the paper was issued by treasury and also to whom the stamp paper was sold/issued by the vendor to whom this paper was given. As the record is not available with the PIO being old records, the PIO/APIO is directed to once again search the records and, if need be, take action against the official who was responsible for not keeping the records accurately in this regard. An intimation/reply to appellant be sent within 20 days i.e. 1.1.2021 as to what is the result of fresh searching/tracing the relevant records. The appeal is disposed off in above terms.
5. Ordered accordingly.
